**Placement Criteria:****Class I (D01)**

Possess one of the following Credentials:

- Adult Designated Subjects (Adult and/or Vocational)
- Ryan Single Subject or Multiple Subject
- Elementary
- Secondary

**Class II (D02)**

Qualification for Class I (D01) and have BA + 30 or 450\* continuing education credits taken as part of an approved educational plan.

**Class III (D03)**

Qualification for Class II (D02) and have BA + 45 or 675\* continuing education credits taken as part of an approved educational plan.

\*Fifteen (15) continuing education credits equal one (1) semester college unit.

Initial placement on the salary schedule shall be at level 1 in the appropriate class.

Level (Step) advancement requires completion of at least 75% of the school year.
